Annexes

Pour constituer la liste des ouvrages sur les fraudes en langue anglaise (n=213) et en langue française (n=34), nous avons consulté deux banques de données : *WorldCat* et *Memento*, ainsi que deux ouvrages dont l'objectif était de dresser la liste des publications concernant les mauvaises conduites en science (Grayson, 1995; LaFollette, 1988). La consultation de ces deux ouvrages nous a permis d'ajouter une quarantaine d'ouvrages supplémentaires à la liste initiale. Lorsque le titre d'un livre nous apparaissait ambigu, nous avons, dans la mesure du possible, consulté la quatrième de couverture ou les données disponibles en ligne. Dans tous les cas, les deux juges sont tombés d'accord, ce qui n'exclut pas qu'ils aient tous les deux torts.
